

Recognizing and Responding to Canada Red Flag Laws: What Everyone Needs to Know

July 28, 2026

10:00-11:00am MT

This one-hour session will explore Canada's Red Flag firearm laws under Bill C-21, which create new legal pathways for courts to issue Emergency Prohibition Orders when someone may pose a danger to themselves or others. The legislation also introduces Emergency Limitations on Access Orders to temporarily restrict access to firearms in urgent risk situations. The session will cover how these orders work, who can apply, the Alberta Court of Justice application process, the evidence required, and the implications for professionals supporting individuals experiencing domestic, intimate partner, and gender-based violence. Reflecting the broad scope of safety considerations, this session highlights how Red Flag laws can support individuals across all ages and stages of life. This presentation is educational in nature and focused on enhancing institutional understanding. It does not constitute legal advice.

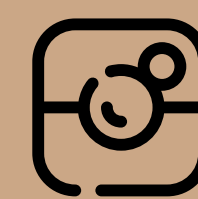
